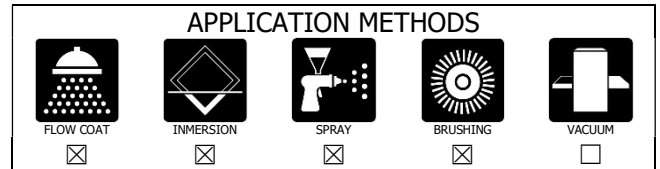
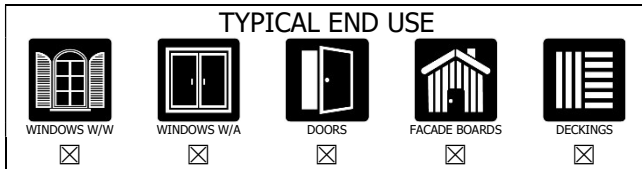

DESCRIPTION

MasqueCombiPrimer is an aqueous industrial wood preservative for new untreated wood designated for exterior use (use classes 2-3) as defined in BS/EN 335-1 such as windows and doors.

The product protects the wood surface and the treated area against wood destroying and wood discolouring fungi and satisfies the performance requirements of EN 599-1. Furthermore, the wood becomes more dimensional stable.

APPLICATION

Pre-treatment: The wood must be clean and free from wood dust and contamination. The moisture content of the wood should be approx. 13 % and should not exceed 15 %.

Application: Brush, dipping or flow coating. It can also be applied by spraying.

Application conditions: The product is delivered ready for use but due to evaporation under processing the solid content of the product must be adjusted with water regularly.

Stir the product well before use. Optimum temperature for products and surroundings: 18-22 °C with relative air humidity of approx. 50 %
